The restaurant reserves the right to use any tables around the party unless other arrangements are made through management and written in the final agreement above. Large parties are booked for three to four hours. As a courtesy to other guests booked after your reservation, please ask your guests to arrive on time and allow for travel and traffic conditions Your deposit is non-refundable if your party fails to call and cancel the reservation by 5:00pm three days prior to the event. A cancellation fee of \$20.00 per person will only be applied if more than one-third of the party fails to show up without a 48-hour notification. A reservation will not be held for your party until contract is returned. Although we can apply separate payment denominations to the total check, we are unable to provide separate itemized checks.
